where I am

I am a constable attached to D.D. Planning, Calcutta Police, since 1986. On receiving a requisition from Bhawanipore P.S. in connection with Bhawanipore P.S. Case No. 87 dt. 6.3.90, I had been to premises No.57A and B, Padmapukur Road, On 7.3.90 I prepared sketchmap and plan of the aforesaid premises and its surroundings. This is the particular rough ~~sketch~~ sketchmap prepared by me. The same is marked ext.1. I prepared this final sketch on the basis of ext.1. Final sketch is marked ext.2. By medhanical process I prepared this blue print of ext.2. Same is marked ext.3. I have shown flat no.3A on the 3rd floor of the premises as mentioned by me above. There are three rooms, one dinning space, two bath-rooms and a balcony and also a kitchen are in the particular flat, and I have shown the same in the map. The balcony faces east. I have used certain abbreviations in the

in the plan and I have explained them.

X-examination on behalf of the accd.

(Attention of the witness is drawn to ext.2)

I have shown a collapsible gate at the door leading to the entrance of flat No.3A. I have shown a pedestal fan in the bed room which is accessible from the drawing room. I cannot say the height of the particular fan. I did not open the glass window in the bed rooms when I visited the flat. There is a vacant space between the 1st and 2nd bed room as shown by me in ext.2. There are walls on both sides of the particular vacant space. One wall is of the 1st bed room and the other wall is of the 2nd bed room. The vacant space which runs from north to south has a glass window on its southern wall. Padmapukur Road is to the north of the particular flat. A By-lane coming from Padmapukur Road runs towards south and approaches the premises where the flat is situated. There is an entrance to the building on the Padmapukur Road and another entrance is there on the By-lane. I measured the space in the ground floor of the building where the lift is situated and security guard sits. The particular space measures 2.8 metre in length and 2 metre in breadth excluding the lift. There are dwelling houses on the eastern side of the by-lane in the vicinity of the premises the flat of which has been shown by me in the map. The addresses of these premises are 57/2B, Padmapukur Road and 57/1, Padmapukur Road. Premises no. 57/2B is a three storied building. The other premises as

The other premises as mentioned by me is also a three storied building. A portion of premises no. 57/2B, Padmapukur road is one storied. The width of the staircase as shown by me in ext. 2 is 2 metres. The rooms in the 3rd floor of the building opposite flat no.3A are visible from flat no.3A. The width of Padmapukur by-lane at the particular place where the aforesaid two buildings are situated is 3.7 metres.

I had been to the flat between 2 P.M. and 3 P.M. I cannot say the distance between the northern end of " Anand Apartment " and Padmapukur Road.
