The deposition of witness No. 7 for the prosecution aged about 27 years taken on eath of soleum affirmation of this 20th day of Feb. 1991.

My native address is village, Amrolla, P.O. Adalcha, Police Station, Belpahari, "ist. Midnapore. My present age is about 27 years. I know the accd. (identified in the dock). His name is Dwananjaoy Chatterjee.

On 5.3.90, I was on duty as a security guard in Anand Apartment at 67A & 3, Faddapukur Nord. My dity hours were from 2 P.W. to 6 E.E nexts morning. On that day, accd. was on duty as a security guard from 6 A.M. to 2 P.M. I used to reside in Monorama School at 23/1, Chakrabaria Road at that time. Accd. used to reside in the Generotor room of Anand Apartment at the relevant part of time Ramdhan' is the liftman of the lift inside Anand Apartment. He used to reside in the same building at the relevant point of time. But Both myself and accd. used to used to wear Khaki Uniform while acting as security guard is Ananda apartment. I was employed by " M/s Security and Thyestigation Bursau" to act as a security guard in

in Anand Apartment. Shymal Karmakar is its proprietor. Supervisor of one company used to check up one duties everybody and note one attendance.

I know " Parekh Mafee ", who reside in Flat No.3A of Anand Apartment in the 3rd floor. I found ' Parekh Maijee Mafee " at about 5.15 P.M. on 5.3.90 coming downstairs by lift. She went out Randhami acted as a liftman when ' Parekh Maijee ' come down by lift.

Accd. came to me 5/6 minutes after Parekh Maijee left. He was dressed in a grey coloured brouser () and a cream coloured () shirt. Ramdhani was near me at that time. Accused stated to me at that time that he would go to flat no. 3A in 3rd floor for contacting our office over telephone from there. Ramidani took the accused upstairs by lift. P. W.6 came to the premises around 5.45 p.m. on that date to check up our duties. He wanted to know from me if anybody by name Bijoy Thapa was on duty in the morning shift as security guard. On my query, P.W. 6 Informed me our Proprietor Skra Shamyal Karmakar had transferred accused from ' Anand Apartment ' to ' Paras' Apartment ' at 1/1, Chakraberia Lane. I informed P.W.6 that accused acted as a security guard in ' Amand Apartment ' in the first shift in the morning. F.W.6 enquired with me as to where the accused was at that time. I reported to him that accused had gone to flat no.3A for contacting our office over telephone, P.W.6 asked mo to call the accused. I tried to contact accused

accused in flat no.3A through intercom. I did not get any response. I shouted saying "Chatterjee " 4/5 times from the gate of the building. Accused came to the 'Verandah' in the flat of "Parekh Babu" on hearing my shouts and by leaning out his face he told me that he would be coming down. P.W. 6 was with me when I called "Chatterjee" by name and had the aforesaid talk with him. 'A short time thereafter accused came down. P.W.6 went ahead to talk to the accused. Accused went out of the gate of the building by side tracking P.W.6. He asked Pati to come out saying that he would talk to him after going out of the gate of the building.

Around 6 p.m., "Parekh Maijee "returned to the premises. Ramdheni took her upstairs by the lift. I heard some shouts in the upstairs a short time thereafter. A little thereafter "Parekh Maijee "brought down her daughter Hetal by the lift. Hetal was on her lap. She was crying and shouting for taking Hetal Parekh to hospital. Some people assembled there. A doctor came in the meantime. Doctor examined Hetal Parekh and declared her kd dead.

As a security guard my duty is to guard the premises and prevent outsiders from entering into the building. We would allow such people to enter only after contacting through intercom the residence of the concerned flat and getting permission from them for the entry of any such people in any such flat. I saw the accused dressed up in a trouser and shirt like.

like this on 5.3.90 at about 5.25 p.m. (attention of the witness is drawn to a gry coloured thouser and a " ghee" coloured shirt). The same be marked material ext. XII (collectively). The aforesaid material ext. be returned to police and direction is given for their production on the subsequent dates of hearing.

X-examination on behalf of the accused person

The trouser and shirt like the one that I have identified in court today as being worn by the accused are available in the marked; Accused was dressed up with a trouser and the shirt like the one I have identified in court today. I cannot say is definitely if accused was wearing the same trouser and the same shirt as I have identified in court today.

"Parekh Babu", "Parekh Maijee", a son of
"Parekh Babu" named "Rhabash Parekh " and his daughter
"Ketal Parekh " were the occupants of flat no. 3A at
the relevant point of time. I saw the sone of "Parekh
Babu" at about 7 p.m. on that day and I saw "Parekh
Babu" at about 8/8.30 p.m. on that day. I knew that
"Parekh Babu" and his son used to go out exampled a
everyday but I cannot say for what purpose they used
to go out. I cannot say as to the time in the morning
hours when they used to leave out as I was not on morning
duty. When I was on morning duty earlier I found both
of them going out of their around 7.30 / 8.00 p a .m.
I was on morning

morning duty about 1/1/2 months prior to the incident.

My duty hours at that time were between 6 a.m. and 2 p.m.

Accused was on the 'B' shift duty, i.e. from 2 p.m. to

10 p.m. at that time. The duty hours from 10 p.m. to

6 a.m. next morning was used to be termed as 'C' shift

and Reasaul Haque was used to be on such duty at that

time. Till 20/25 days prior to the incident the duty

hours for the security guard in the building were

spread over three shifts namely 'A' shift, 'B' shift

and 'C' shift. On the date of the incident I was on duty

for the 'B' shift and also night shift. Accused was on

duty for the 'A' shift. On the previous day I was on duty

for the 'B' and 'C' shifts.

There were two types of servents working in the flats of the building. Some of them used to work in the flat and stay there and take their moals there while the others used to work in their fets and stay in the building downstairs and eat their meals by bringing the same from the respective flats where they used to work. I knew all the servants working in the flats of the building. I knew Ramesh and Panchu. They used to bring their meals from upstairs, and eat the same and stay downstairs. Ramesh used to bring his food from the flat of " Parekh Babu". Panchu used to bring his food from flat no.4C. Shakaria Babu was the owner of that flat.

I never went inside the flat of " Parekh Babu ".

I was not aware that " Parekh Babu " and his son were

were not used to be in their flat in the afternoon everyday. On Sundays and holiday, and durin their allments they used to remain in their flat in the afternoon. I cannot say if " Parekh Babu " and his con had been suffering from some stlamm - ailments on the date of incident. I did not see Bhabesh Parekh to get nown from his flat on the date of the incident from 2 p.m. to 7 p.m. and ' Parekh Bauu " from 2 P.M. to 3/8.30 p.m. Daughter of " Parekh Maljee" used to remain inside the flat when she used to leave flat around 5/8.15 p.m. except on holidays. I do not remember which day it was on 5.3.90, I never contacted my office over telephone from Anand Apartment. I cannot say if there is any telephone : .r ' Anund Apartment' wherefrom office can be contacted. Except the intercom we in not have any other form of telephone connection in downstairs in ' Anand Apartment '. There is also intercom arrangements in " Paras Apartment " but no arrangement of telephone is there for the gardar guards. There is a telephone in the office of ' Cr i Company ' at Mahandra Road Shere accused used to act as a security guard at Aught. There are some other offices and also dwelling houses in the particular building. " Purekh Maijee " used to return flat between 6 p.m. and 6.30 p.m. I did not know on the day prior to the date of incident that accused had been transferred to " Pares ipartment", I came to know this from P.W.6 when he tame to check up our attendance on 5.3.90. I was not required to

to contact anybody in the apartment on 5.3.90 between 2 p.r. and the time when I tried to contact accused at flat no.3A. I got a call from flat no.5C through the intercom on that day at about 6 I did not go to flat no.50 on getting the call. I did not tell accused when he wanted to go to flat no.34 for using telephone ther: that " Parekh Maljee" was not inside the flat and that he we should not go there in her absence. I 41d art try to contest flat no.3% through interesm when accused gave out that he would go to that flat for using the tele-home there for contacting our office. For the servits and the security guards it was not necessary to contact any resident of a flat but we could straighthay visit such flat. The servants working in the flats in the building and the security guards like us used to go upstairs by using the staircase or by lift.

while giving statement that I tried to contact the accused in flat no.3A after P.V.6 came, through intercommend that I went near the gate and called the accused by his name. I do not remember if I had stated to police that I called the accused by name from the place of my duty, not a fact that accused did not resemble to my duty. Not a fact that accused did not resemble to my call saying that he would be coring down by coming out in the "Verendah" of flat no.3A when I called him by name. I know Thakaria Babu, a rup tent of one of the flats of ' anand Apartment'. They a maid servant who used to work in his flat. Not a fact I had an

That an illicit connection with the aforesaid main carriet. I cannot say if accused complainted against me to in karia Babu. Not a fact that I was transferred from ' Anand Apartment ' due to my illicit connection with the particular maid servent. Not a fact that I tried to transfer the accused from ' anand Apartment', and that accused did not visit flat no.34 on the data of the incident as stated by me. Not a fact that whate ever I have stated about the accused in court today had been tutored to me by police and the same are false and the same have been stated out of gruing against the accused.
