I am aged 39/40 years now. I have been operating as a lift men in ' Anand Apartment ' 'er the last 7 years. I reside in a quarter s. .side the premises of ' Axim Anand Apartment '. I am the only lift can in the building. I am also known as he ham Yeday. My duty hours are from 8 a.m. to 2 p.m. and ageing from 4 p.m. to 8 p.m. I know the accused (identified in the dock). About a year back, 5/6 days prior to the date of Holi, Hetal Ferekh, daughter of " Porek' Maijee" Hed. Accused used to work as a security guard in our building _. that time. On the date of the Inc ient accused was; on duty upto 2 p.m. Apart from the accused, Marmy was the other security guard in the building. Marma was on duty on the particular day from 2 p.m. " Parekh Babu " was the occupent of flat no.3; in the 3rd floor, " Parekh Maijee" also used to reside in the same flat. I brought down " Parekh sijes" on the date of the incident about 10/15 ml ther after I for charge of the lift at 4 p.m. She used to go out every ay

around that time. She had stated to me that she used

able used a go out to visit a temple. I found the abouted standing near the main gate by the side of a car when I reported for duty at 4 p.m. I also saw Morona with the accused at that time. I did not take the accused to 3rd floor by my lift that day. While I was taking the mother of Aruna Shah by the lift, I found accused coming down by the staircase in the 3rd floor around 5.30/5.45 p.m. When I came down with the lift accused was found downstairs. I found Supervisor of the security guards namely accused and Moron standing hear the gate of the premises of 'Anand Apartment'. There-after the Supervisor and the accused went out of the gate of the premises of 'Anand Apartment'.

About 10 minutes thereafter ' Pareth Maijes' dame out from the temple and ' out her by will't to 3rd floor. She started pushing the ralling bell of her flat. Then ' Pareth Maijes' dame dadt from the temple I reported to her I had a quarrel with the accused over a lock in flat no. 5% of the building. I requested ' Flook had be to ask ' Pareth Babu' to release opening of our respective dues to the release of the flat of the accused by paying of our respective dues to the release of the flat had a bout 7 p.m.

I did not tell police that I took the accused by my lift to 3rd floor and that accused proceeded towards the flat of "Parekh Rabu". I did not tell police that I found Pati of security company coming to the building and talking to Muram. I did not tell police that I had informed "Parekh Raijes" when she came to the lift that accused had not to her flat.

" Parekh Maijee " started shouting after ringing the calling bell 2/4 times. She enquired of me as to hat had nappened and that Hetal was not opening the door. Servants, female occupants and children residing in the flat came there. The door at the entrance of flat of ! Purekh Maijee ' was broken of a by Panchu, Ramesh. I did not participate in the act of breaking open the door of the flat. I did not tell police that myself, Panchu and Ramesh broke open the door at the entrance of the flat. From outside at the entrance of the flat I could see Hetal lying on the floor inside the hall of the flat, ' Parekh Maijee ' brought Wetal and came downstairs by using my lift for taking Hetal to hospital. Many prople ascembled at that time. ' _rakh Mailes ' and let I were inside the lift. I found stains of blood ... the face of Hetal. Doctor came and declared intal

Not a fact that to save the accused I have stated falsely that accused did not ask me to take him to the flat of "Parekh Maijee" in 3rd floor by my lift and I did not see proceeding towards that flat and that I did not report to "Parekh Maijee" on her return from temple that accused had gone to her flat and that I had a quarrel with the accused on the date of the incident over a look in flat No.5A. The entrance of each of the three flats flats flat all the floors of the building is we ble when the door of the lift is opened on reaching the particular flat.

Texamination on behalf of the accused

Texacersly illiterate. I can sign my name only.

I cannot read. I sign in Hindi. Accused was not there
when I came to work as a lift man in ' whend Apartment'.

I camet say how long after I juined accused during to
work in the particular building. Services of the accused'
had been terminated once after he worked for three years.

I cannot say how long before the incident this happened.
For 5/6 months during my period of employment security
guards were not provided by the company to which accused
belonged but security guards were provided by different
company at that time.

No lift man works between 2 p.m. and 4 p.m. and after 3 p.m. The lift that I operate is a automatic one. During the period of my absence, it is operated by any one using it.

I found 'Parekh Babu 'leaving for his shop around 8/8.30 am on the date of the incident. Bhavesh Babu, son of Parekh Babu also went out on the date of the incident. But I cannot say at what time he I ft. I cannot say where I he went out at noon or in the afternoon. 'Pa. th Babu' returned around 7.30 / 8 p.m. on the date of the incident. Bhavesh Babu came back before his father. Only daughter of Prakesh Maijee used to remain in the flat when she used to go out in the afternoon.

Police wrote my statement. I cannot say what statement police wrote, lolice did not read over what had been written as max my statement. I do not know buglish. I had stated to police that I found the accused in the staircase in the 3rd floor when I took ap mother of Arune Shah by my lift. Not a fact that I did not see the accused in the staircess in the 3rd floor when I took up mother of Aruna Shah to her flat. I found the accused proceeding towards the Supervisor who was standing near the place where the sec rity guards stand for their duties, when I came down with the lift after the mother of Aruna Shah got down from the lift i. the 3rd floor. I had stated to police this particular fact. I had a quarrel with the accused at 12.30/1.00 p.m. on the date of the incident. Flat No.5A was not occupied by anybody on the date of the incident. The key of the lock of that flat was with Bipin Bhimani of our company. He was the promotor of the construction of the building. I do not know anybody by name Mahash. I know one Mr. Zaveri. You a fact that I i used to bring female persons from outside to the vacant flats in the apartment and that

and that accused had reported against me on such conduct of mine and that I lost my employment for this reason and that since January '90 myself, Rasaul Ker and Mirmi made conspiracy to implicate the accused in a false case.
