My name is Maloy Mukherjee (S.I.) son/wife of Bimal Mukherjee

My age is 42 years. I reside at 188/189 G.T. Road Salkia Road.

I am a sub-inspector of Police attached to Chowanipore P.S. since 1988.

On 5.3.90, I received as oral instruction from the officer in charge of Bhows tpore Police Station to isit premises no. 574 & 3 Padmapukur Rd., as an information was received in Bhowanipbre P.S. about the murdered of a person at the particular Pudda Pukur Rd. At about 10-35 P.M. I went to the aforesaid place. I found & b-Inspector G.P. Some in the ground floor of the said building. I came to know from the aforesaid person that the Officer in charge of the Bhowanipore Police Station was in the third floor of the said building. Under the order of O.C., Showanipore P.S. I prepared this seizure list (witness identifies the document barked ext. "O" for iden' fication)

in presence of witness for seigure of the clothings of the deceased, as described in the seign re list. The particular seizure list is marked ext. 11. Under the orders of the officer in charge Bankura Police Station, I recorde some statements of the witness. I was asked by the O.C. to search for the accused in some nearby places. I, accompanied by Dhananjay Murma, another security guard of that building went to Maherdra Rd, Chakraberia Rd, and Chakraberia Lane, for apprehending the arcused. I did not find the accused there. I arranged for despatch of the deadbody of the victim to S.S.K.M. Hospital fro the particular building. A constable of my police station also accompanied me. I arranged to keep the deadbody of the deceased in cooling namber at S.S.K.M. Hospital and thereafter came back to the place of occurrance. Thereafter, I along with other police Officers returned to the P.S.

I reached S.S.K.M. Hospital with the dead-body of the deceased at about 2.10 J'clock at night. I did not meet the doctor. I kept the deadbody in the cooling chamber of the Hospital after getting paraission of the Surgeon Superintendent over talephone. There is nothing in the basis flary to show that I had a talk with the Surgeon-Far whiten-

permission for keeping the deadbody in the cooling chamber. The deadbody of the deceased had been kept by the ward Master in the cooling chamber and I recorded this fact in my C.D. I left S.S.K.M. Hospital after the deadbody was kept in the cooling chamber. I cannot say when the deadbody was brought out from the cooling chamber afterwards. The deadbody was at the place of occurrance up to 1.55 O'clock at night. I did not see the G.D. entry in which the information relating to the murder of a person at 574 & B Podd(Publication had been incorporated.
