I read upto Class-XII. We are three brothers and four sisters. On 27.3.89 I got married with Purnima Mukherjee D/o Anil Mukherjee of vill: Jamadaha, P.O. & P.S. Chhatra, Dist. Bankura. My own grand father's name is Ld. Rakhal Chaterjee by another grand father's family and families ofmy uncles camelyil) Bhutnath Chatterjee, (2) Ramchandra Chatterjee, (3) Ld. Krishna Chandra Chatterjee also stay in our village. The have got their separate house in the village adjacent to our house. We have 25 bighas of cultivated land.

In the year of 1987 I joined as a Security guard in Security end Investigation Eureau of 1, advanath Saha Road, Lake Town. The firm being owned by Sri Shyamal Karkar I was performing duty at anend Apartment at 57, A & B, Paddapukur Road. Bhomanipur, Cai-20. Sri Nagardas Parekh has been living in flat No.3A of said spartment with his family. He had a your daughternamely Hital Parekh shows a school student. I had it of meskness on her. I used to become very much excited seein; her. Finally I started tessing her on her way to school and coming back. I observed that she became very much annoyaden my behaviour but I could not resist myself. On 4.3.90 I got transfer order from my owner through Rezaul Hoque to the effect that I will have toperform duty at Paras apartment from 5.3.90. I understood that it was the result of teasing Hetal and I also

understood that Hetal reported everything to the guardism. I became verymuch angry upon her and decided to take revenge on her. I kpew that Heal remained alone in their flat in the afternoon hours when her mother used to go outside everyday. I coose that period for taking revenge. On 5, 3.90 I performed outy at An and Apartment violating my transfer order. An and Around 06.00 hrs. ob. 5.3.90 I shifted my belongings to a nearby abandoned place from the generator room of said building a I decided to flee away after rapingand killing Hetal. 13.00 hrs Heal returned from school. At 14.00 hrs. Maren took up duty from me. I went out of the apartment wearing my working Khaki Uniform. Collected my Belongings from the nearb place and went to Victoria. I changed my dress then and put on cream coloured full bush shirt and grey coloured prouser. Then I kept my belongings concessed in the garden of victoria Park. Then I took meals in a road side hotel at Dharmatula. around 17.00 hrs I came back near An and apartment and maintained watch to akk see when Hetal's mother goes out. Around 1 17.15 hrs. she went out. I further waited for few minutes. Then I very casually entered the apartment and went to the flat No. 34 by lift giving false plea to ring up to our 5"fice from that flat. Reaching the flat by lift operated .. by Ramdhari- liftman I rang the door bell when Hetal opened the door. Seeing me he tried to close the door but I fix forcibly entered the flat and caught hold of her and asked not to shout. But she went out of myclutch and emered in a bed room. I was traing to bring her under control and at the scuff.in; started between us. Due to sculfle my wearing neck-chain which was given to me by Gora of flat No. 3B of said Apartment, and one buttom of myshirt torn down. I of ered a blow on hor face and she started bleeding. But still then she was giving

giving resistance. I then pressed her face on the hanging creals of that room and she sustained further injury. At that she became to some extent tires. I then foreibly laid her on the floor and forcibly put her wearing panty out of her person. Then I raped her. But with she was still givi: registance. After completion of rape I pressed her south will one and pressed her neck with mother hand a in spite of he resistance. In that process she cied. I thun got up and raised my ponish with her panty and three the same. Then's I sterted searching for valuebles in a simirah of that room. I got one lacies Ricoh Wrist watch. Memphile I heard the calls of Muram from ground floor. I came to the balcony of seld flat and from the beloony saw Pati - the Supervisor came. I told them that I was coming. I further searched the almirsh but no other valuables could be found. I then came out of the flat and locked the coor pulling the same from outgid: I came down the ground floor. As soon as I came down Pati approached to talk to me. But I bye-passed him hurriedly and come outside the building asking Pati to come ouside for talk. I talked to Pati on the road and on his queries 1 replied some false at allby and then ceme to Victoria. I collected my belonging from Victoria and came to Househ, Laft Rallmay Station: "le"t Calcutta by Jagannath Express. Thereafter I was rogaing in differnt places and in the night to sleep in the cifferent Rail way station to evade my warrant. Meanwhile I stitched a buttom in mystirt shirt from which one button was torn come at the time of incident of 5.7.90. On 10.5.90 I ceme to my native place thinking that police was no longer searching me. After returning to my

native place I came to knor that Police relied our native

place on several occasions in search of me. For that reason I used to sleep at night in my uncle's house.

I kept the locies "Ricoh" wrist watch with golden metal band- which was stolen by me from flat No. 34 of Apand Apartment on 5.3.90, on the rack of our house. I also kept my comments, by wearing which I committed rape on Hetal Parekh and killed her, on another rack of our house. I all point out those racks and said articles. 7.
