1. NATURE OF CRIME.

On 5.3.90 in the afternoon the mother of the victim girl Hetal Parekh w/o Sri Nagardas Parekh of flat No.3A, Anand Apartment at 67 A & B, Pacchpukur Road, Cal-20, went out of their flat leaving her only daughter Hetal alone in the flat. At about 18.06 or so she returned home, found the door closed and none opened the door even on calls. The door was forced open and the victim girl Hetal was found lying in a pool of blood in their bed-room on the floor practically in naked condition. Her torn "Panty" having some hair and stains was found lying on the floor near the entrance door of the flat. There were some injuries on her person also. The Autopsy Surgeon opined the cause of death was due to effects of smothering with strangulation ante-mortem and homicidal in nature. The ladies Ricoh wrist watch had also been stolen from the flat. The victim girl was also raped. Accused Dhammajoy Chatterjee has been arrested and he is in J.C. till 7.6.90.
