My name is Sri Bhavesh Parekh non of Hagardas Parekh.

My age is 20 years. I reside at 57 A&B Faddupukar Rd.

lat No.34 3rd Floor
Calcutta-20

Police Station Bhawanipur District Calcutts My occupation is Student.

I a studying in Class- XII commerce in Bhawanipore Musational Society College. I am 20 years old. th 5th Agreh, '990, I was a student of Class-XI of the aforesaid college. I used to reside in flat no. 3A, Anand Apartment at 57A and B, Padmapukur soad with my parents and sister Hetal Parekh, since deceased. I know the accused ( identified in the dock ). He was the security guard of " Amend Apartment " before and at the time of mincident. On 5th March, 1990, I left for my college at about 5.15' 6,20 in the morning and returned to my residence around 11/11.30 A.M. Accused was on duty at that time, about 12,30 I left for my office at 71, Canning Street, shop No. C-32 under the name and style " Alankar " at Bagri market. I used to help my father

father at that place.

At about 6 O'clock in the evening on the same day my father left the aforesaid shop room saying that he would purchase medicine and proceed to our residence. He asked me to close the shop at 70 clock in the evening and thereafter to proceed to my residence, Around 6.45 P.M. I got a message over telephone that my sister had been murdered in our flat. I did not ask for the name of the person who rang me up. I closed my shop quickly and came to my residence. I found many people assembled outside our apartment. On entering the apartment I found Murau, the security guard on duty. I found my mother sitting in the lift chamber weeping. My deceased sister was on her lap and she had injuries and blood stains on her face. On enquiry from my mother I came to know that around 6.15 / 6.20 P.M. she had gone to " Lakshmi " Narayan Temple " leaving my sistir alone in the flat. She had also reported to me that the accused had come to our flat on the pretext of using our telephone and that on her return my mother found my sister lying dead. I took my mother and deceased sister up-stairs by the lift. The dead.dy of my sister was laid on the cot in her room and a sheet was placed on her body.

The room of my sister is on the wastern side of our flat. My mother was crying : if I tried to console her. She had also stated to me that two local doctors had some and pronounced my sister to it. I range up my

I rang up my relatives and friends. The friends whom I rang up are Mr. Anish and Hiten and the relatives whom I rang up are Mr. and Mrs. Modi. I asked the aforesaid persons to come to our flat saying that my sister was mardered in our flat. My father came back to our residence at around 8.30 f.M. My mother told him what had happened. My father rang up police after he was relieved of the shock. Around 8 9.30 f.M. police came to our flat.

These are my signatures ( witness identified his signatures in the seizure lists dated 5.3.90 and 6.3.90). The aforesaid three seizure list: be marked S, T and D respectively. Signatures of the witness thereon ha marked exts. 9/1, 10/1 and 11/1 respect. 1y. My friend Rajiv also signed on the aforesaid seizure lists. I know his signatures. Under the aforesaid seizure ists one cradle and one chain, one cream coloured buttom with four holes and stains of blood had been taken from the floor of the room of my father. From the drawing room in our kilat at torn panty with stains of blood, a broken inch and sorews were seized and from my sister's room her undergarment from her person had been seized. All the articles were seized under the aforesaid three seizure lists.

( at this stage one sealed packet is opened in court room and broken look with screws are brought out therefrom).

This is the broken laten with screws which were lying

lying on the floor of the drawing room and seized by the police. The same be marked material Ext. IX ( collective-ly).

( Another seleed paper is proken at this stage and a cream : ploured buttom with four holes is brought out therefrom ).

This particular button had been seized from the room of my father by police. Same is marked material Ext. X.

(Another sealed packet is also broken and a chein is brought out therefrom). This particular chain had been seized from the run of my sister. The same be marked ext. XI. The particular chain and the buttom (material Exts. X and XI respectively) do not belong to any member of our family. This cradle (witness identifies material Ext. VII) had been seized from the room of my father.

This is my signature ( witness identifies his signature in the seizure list marked R for identifition.) Signature of the witness thereon is marked ext. 8/2. This seizure list relates to seizure of the key of the door latch which was broken. This is the particular key ( witness ident' fles material Ext. VIII).

One form who used to work in a flat opposite to our flat had been brought by police to our flat in the same night on 5th March, 1990. He identified the chain seized from the room of my father as belonging to him.

I put my signature on this document ( witness identified his signature on the inquest report.) The increst report is marked U for identification. Ignature of the witness thereon is marked Ext.12/1. My friend Rajiv also signed on the aforesaid seizure list. U. The instruction of my mother I wrote this letter addressed to the Officer-incharge of Shawanipore P.S. ( witness id tifies the letter marked \* Y for identification). The particular letter be marked ext.3. This is the photograph of my deceased sister ( witness identifies the photograph marked material ext. I/1 ).

Cross-examination on behalf of the Accused.

I was inside our flat since I returned in the evening. Police left our flat around 2.30 0'clock at night. Policeum completed preparation of seizure lists, inquest report etc. before they left our flat. Besides preparation of the seizure lists and inquest report police also took statement of myself, my parents and other persons. My statement was recorded after the seizure took place. After about 1.30 0'clock at night my statement was recorded. I do not remember at what time the statement of m, father was recorded. The statement of my father was recorded in the same night. I do not remember if his statement was recorded before or after the seizure. Around 10 0'clock in the same night the statement of my mother was recorded in my room.

The statement of my mother was not taken in my presence. My mother was sitting in the room of my sister and thereafter she was taken to my room when poline came. I cannot say when the recording of the statement of my mother was over. I knew Gouranga Pal alias Gora for about two years and a half before the incident. He never worked in our flat. I know Aruna Shaw who is my neighbour. She resides in a flat opposite to our flat. I knew aruna haw for about two years and a half prior to the incident. Very seldom she used to visit our flat. Myseli, my sister and father never visited the flat of Aruna Shaw during the period of 2; years prior to the occurrence. My mother used to visit the flat of loung Shaw sometimes for meeting the mother of Aruna Shaw who was an old lady. I do not remember if I had stated to police that Gora came and identified the chain as belonging to him. Not a fact that I have been tured to say that Gora came to our flat in the night of the incident and identified the chain as one belong to him. The chains of the sort that I have been identified in court and had been identified by wra in our flat has belong into him are available in the market. I reached my flat in the night of the inclient 5/10 minutes at r 7 O'clock. My mind was disturbed when I saw the dead body of my sister. I do not remember how long after I reached my flat I rang up my fr' mds and relatives whom I have named in my examination ' chief. This communication was made prior to the arrival of my father in the flat. Mr. and Mrs. Modi used to reside near Hazra,

reside there now. I call Mrs. Modi as aunt by courtesy. I do not remember if Mr. and Mrs Modi came to our flat before my father arrived in the night of the incident. I do not remember if I narrated the incident to Mr. and Mrs Modi then they use to our flat. I do not rend in the same school with Rajiv, Anish and Hiten. Anish belongs to our society, that is the Kapol society and through Anish I develop acquaintance with Rajiv and Hiten. Rajiv and Hiten do not belonging to our community. Hajiv, Anish and Hiten never visited our flat before the date of the incident. I do not know till now as to the identify of the person who had given me the message over telephone about the death of my sister on the date of the incident. I came to know from my mother as to the identity of the person who might have killed my sister. On 6.3.90 Ihad been to Bhowanipore police station to lodge a complaint about the theft of the wrist watch of my mother. My father and some other relatives were with me at that time. The other relatives included Mr. Modi, Mr. Janak Kacharia, who is the husband of my elder sister, Mr. Prakash Sanghvi, who is the husband of my another elder sister, Mr. Dauletram Vora, my maternal uncle and offers whose name I cannot recall. I never had been to Bhowanipore police station prior to 6.3.90. I have a scooter. I came back to my residence in the night of the incident m the same secoter. It took about 15 minutes time for me to come

Bhawanipore at the relevent point of time. They also

to come back from the shop to my flat on the date of the incident by the scooter. I reached my flat around 7.10 p.m. I do not recall if it occurred to me that I should to Showanipore police station immediately after I came to know from my mother \_ out the identity of the person who might have killed my sister. I do not recall if it occurred to me that I should give a ring to the security agency which provided the security guerd in our apartment to inform them of the name of probable assailant. I do not remember if I had any talk with my father about the incident when he reached our flat. I do not recollect if I was present when my father rang up Bhowanipore police station. At what time and when my father rang up Bhowanipore police station in the night of the incident I cannot say. Not a fact that the chain (material ext.XI ) was not recovered from my flat. I do not remember if the measurement of the chain recovered from our flat had bee. taken by police. I do not remember if the chain recovered from our flat and Identified by me in court today had any identification marks on it.

Tam very much acquaintted with cream colour, There are differeences between cream colour, pink colour and white colour. Cream colour buttons are available in plenty in market. Not a fact that the button that I have been identified in court today — not the button which had been recovered from our flat in the night of the Incident. The process of seizure of articles started around 11-45 C'clock at night and ended around 1.30

1.30 O'clock. I do not remember precisely at what time the seizure of cradle, button, chain and blood had been made from the room maxix of my father. I do not remember how long after police came the articles as stated above had been seized. Now a fact that that I have been tuted by my father a police and I have given false evidence.
